\*Cash awards for placings 1-6 \*Appropriate tack is required

**\*All horses on grounds must show proof of current negative Coggins, original plus a copy to leave at grounds**

\*Helmets recommended, boots required

\*Proof of age required for junior horse (vet statement or registration papers) before the start of any entered class.

\*Stallions must be handled by person 19 or older.

\*All dogs must be on a leash.

\*Riders may cross enter Western Pleasure and Ranch classes. Ranch is judged on forward movement.

All persons on said grounds are considered participants subject to Wisconsin Equine Liability Law which states: A person who is engaged for compensation in the rental of equine equipment or tack or in the instruction of a person in the riding or driving of an equine or being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risk of equine activities, as defined in Section 895.481 (1).
